ENTRIES AND SPECIFICATIONS

Accepted mediums: The entries may be any type of 2-D media: drawing, painting, print-making, mixed media, and relief sculpture.

Accepted sizes: 2-D surfaces measuring no more than 72" x 72".

Number of entries: Each registered surface is \$24.00. Artists may register up to 5 blank surfaces. Only one final work will be entered into the competition.

Presentation: Work may be framed (preferred) or un-framed, however works on paper should be presented on a sturdy surface such as foam board or other hard surface. Due to the 24-hour period, works not yet dry will be accepted.

All artists are required to be present at the reception and awards presentation. Due to the nature of the competition some paintings may still be wet and should be monitored closely so that the public does not touch the artwork. MAC will not be responsible for any damages.

PARTICIPATON AGREEMENT

- I am including a portfolio of 5 images, either as slides or digital images on a cd.
- I have participated in Open Studios and therefore do not need a portfolio of images.
- I have thoroughly read the GUIDELINES and am submitting the application by March 27, 2009 with the \$24.00 fee per blank surface submitted.
- I understand that although I may register up to 5 surfaces at a cost of \$24.00 each, I may only enter to the juror one final piece.
- I agree to arrive between 9-11am, April 24, 2009 at the Metropolitan Arts Council for the registration with blank unmarked surface(s) measuring no more than 72" x 72".
- I agree to work between 11:00am of Friday, April 24 to 11:00 am of Saturday, April 25.
- I agree to abide by the decision of the juror selected by MAC as to the winning artwork.
- I agree that my entry will abide by the entry specifications on the next page.

- I have supplied a SASE with appropriate postage for the return of my slides/cd.
- I will pick up my images at the April 24th registration.

I agree to a 20% commission for MAC in the event that my piece in the exhibit at MAC sells.
